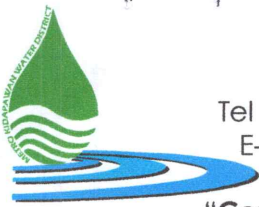

JOB ORDER CONTRACT

KNOW ALL MEN BY THESE PRESENTS:

METRO KIDAPAWAN WATER DISTRICT a Government-Owned and Control Corporation (GOCC) duly organized and existing under and by virtue of Presidential Decree No. 198 as amended, with office address at Lanao, Kidapawan City represented by its General Manager, **STELLA M. GONZALES, MPS**, aduly authorized for this purpose, herein called the WATER DISTRICT.

AND

VMTECH SALES AND SERVICES, a duly organized and existing entity under and by virtue of the laws of the Republic of the Philippines with office address Purok 30, Poblacion, Makilala Cotabato, represented by its Owner/Proprietor, **VAL ANTHONY R. AGUILON**, herein after called the **AWARDEE**.

WITNESSETH:
